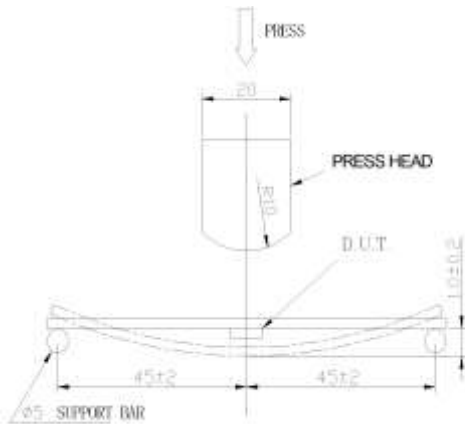

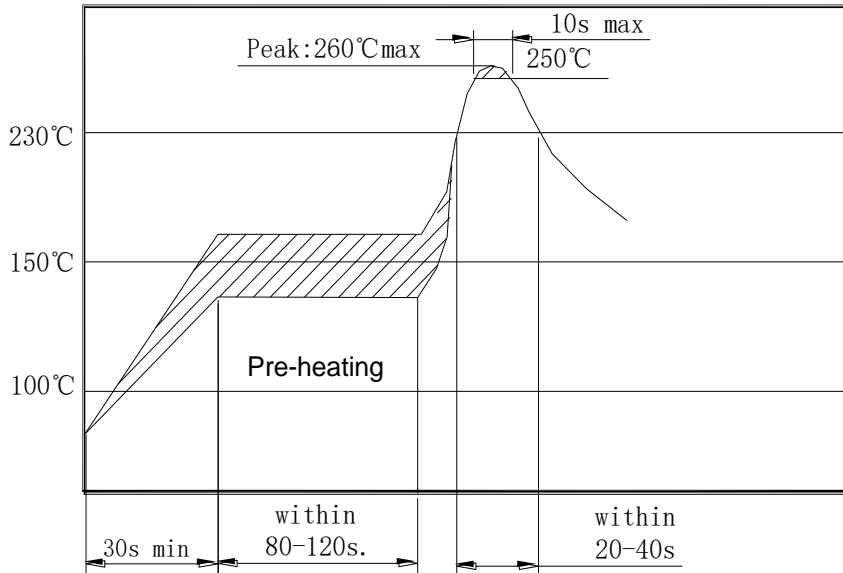
Soldering Test



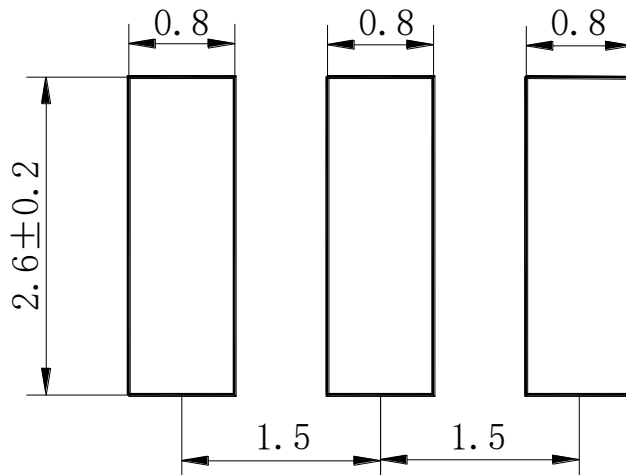
Board Bending



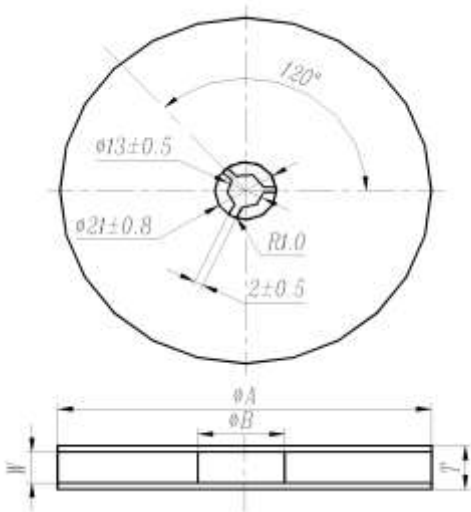
SUGGESTED REFLOW PROFILE (For Reference Only)



RECOMMENDED LAND PATTERN

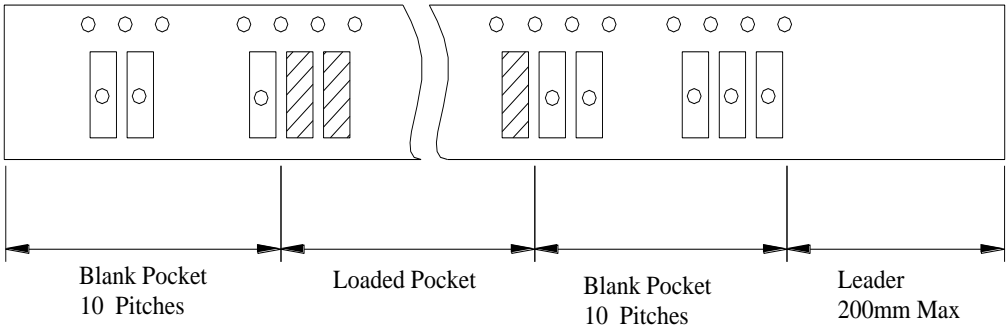

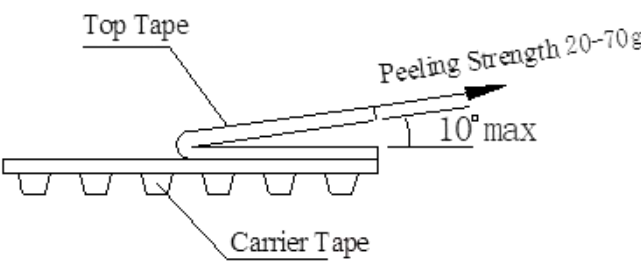
