

## **MEASUREMENT CIRCUIT** – FOR REFERENCE ONLY




#### **RECOMMENDED SOLDERING PROFILE** – FOE REFERENCE ONLY






## TYPICAL LOW-POWER TRANSMITTER APPLICATION - FOE REFERENCE ONLY





 Note: The curve shown above accounts for resonator contribution only and does not include LC component temperature contributions.






