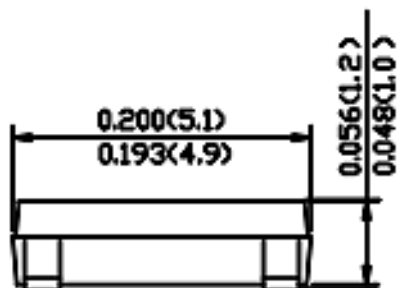

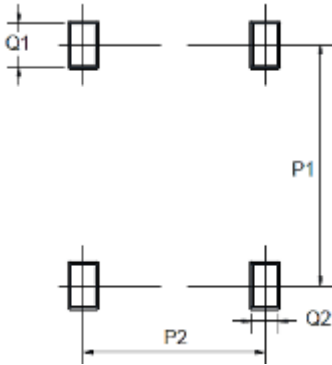

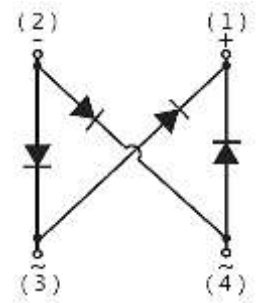

Fig.1 Average Rectified Output Current Derating Curve

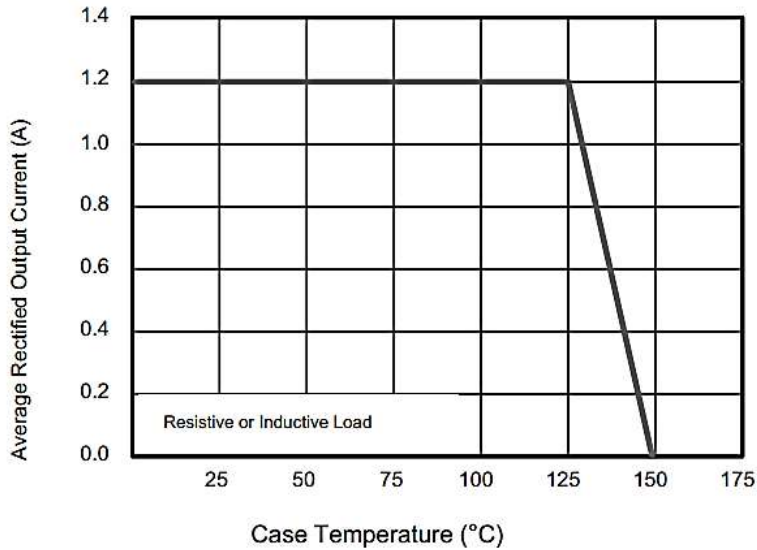
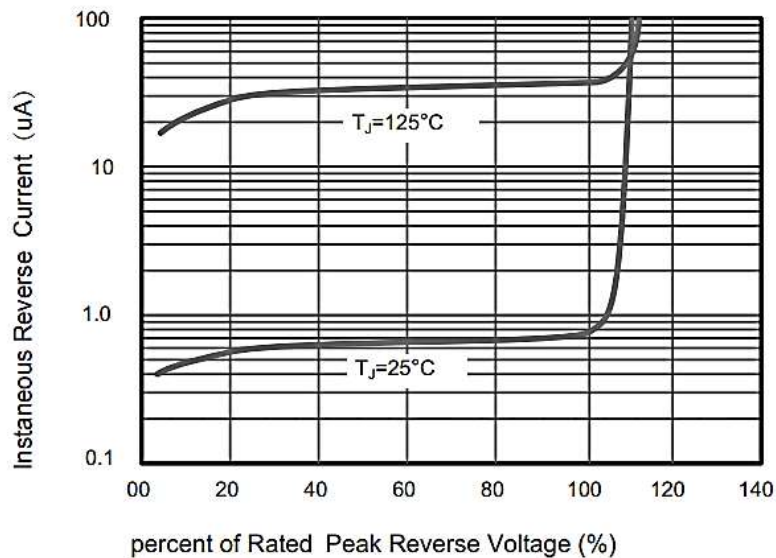


Fig.2 Typical Reverse Characteristics

Fig.3 Typical Instaneous Forward Characteristics $T_J=25^{\circ}\text{C}$

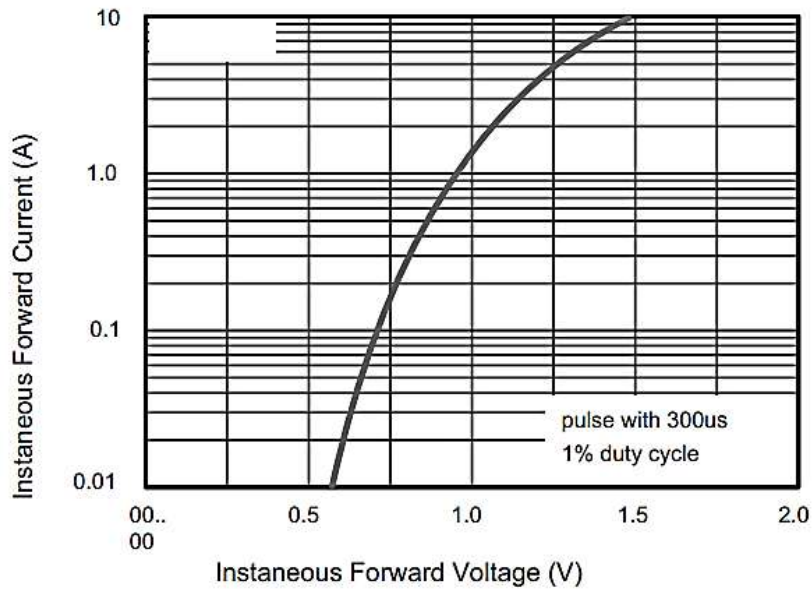
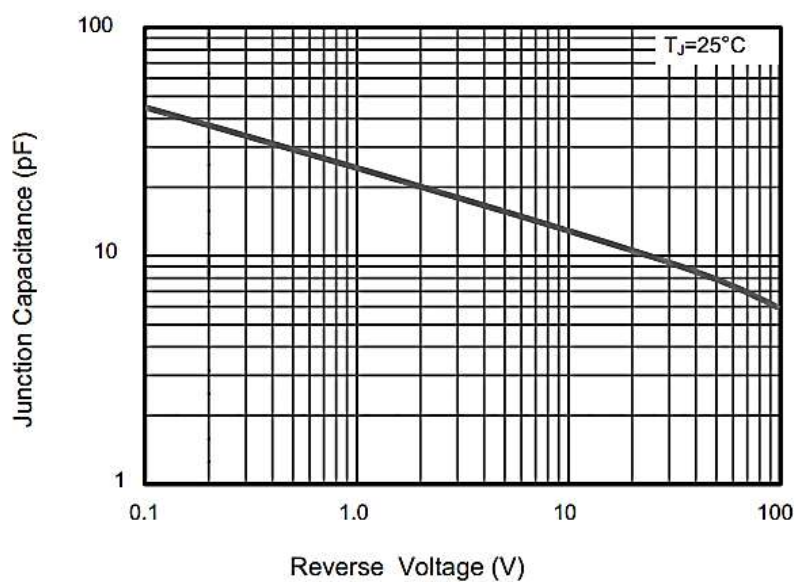
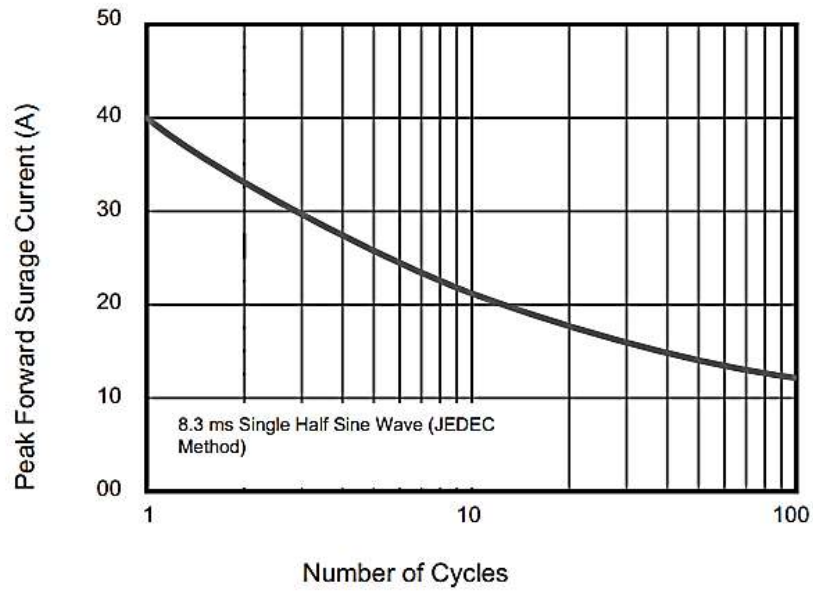


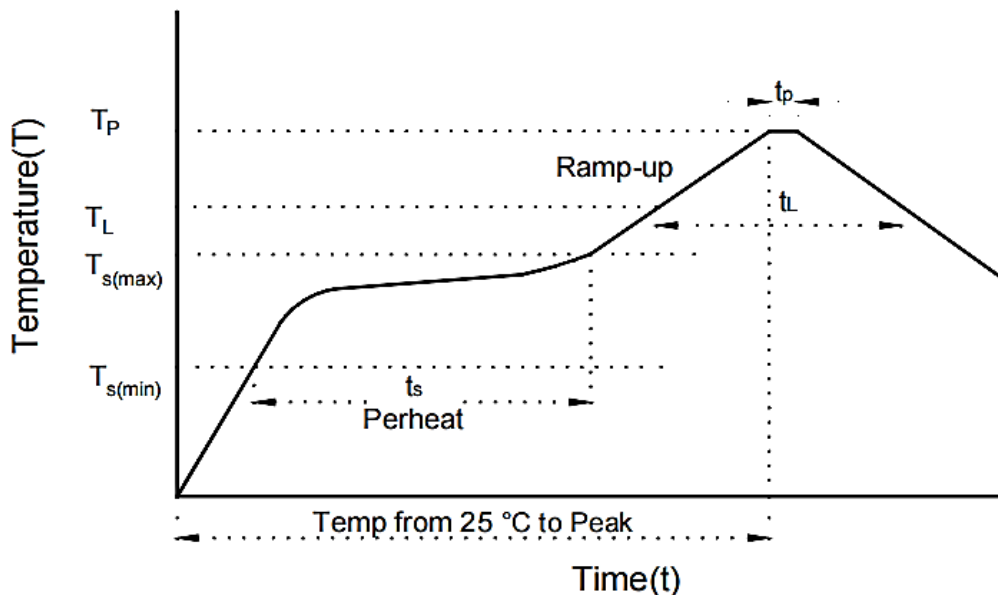
Fig.4 Typical Junction Capacitance

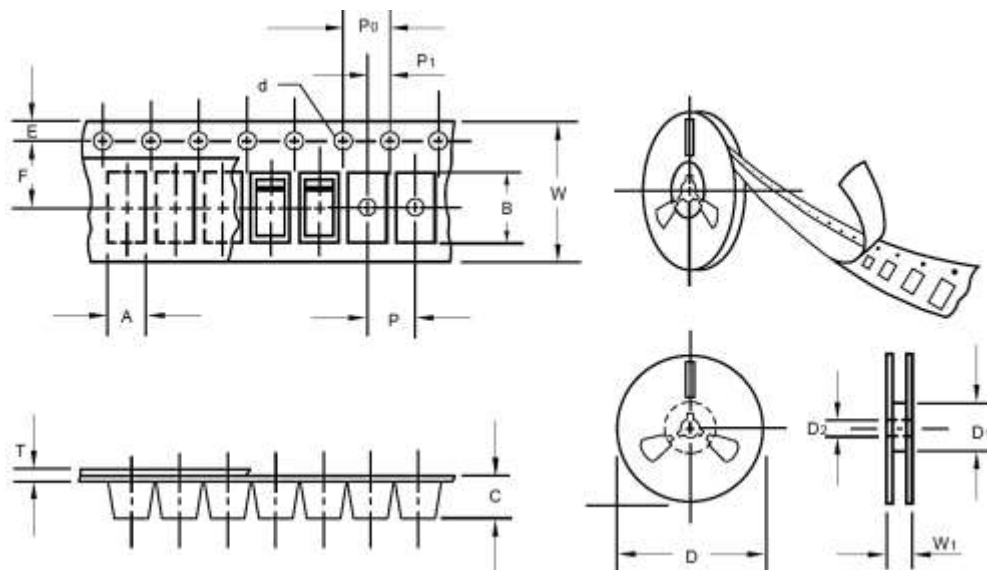
Fig.5 Maximum Non-Repetitive Peak Forward Surge Current
