Fig.1 Average Rectified Output Current Derating Curve





Fig.2 Typical Reverse Characteristics






Fig.4 Typical Junction Capacitance


Instaneous Forward Voltage (V)





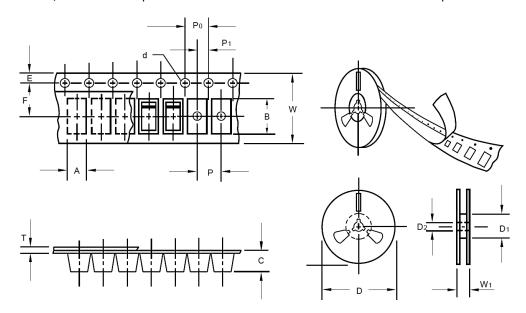
